Speakers



Dr. Costantino Grasso – Assistant Professor in Law, Associate at CFI, Coventry University

Costantino teaches Corporate and Financial Crime, and Corporate Governance at Coventry University. He is also the Global MBA Module Leader for Corporate Governance and Ethics, and for Ethical Leadership at the University of London. He is the editor in chief of the Corporate Social Responsibility and Business Ethics Blog and member of the Society of Business Ethics (USA). As of June 2018, Dr Costantino Grasso

has been appointed as an international expert in the area of corruption and good governance by the Council of Europe, Directorate General Human Rights and Rule of Law. He also serves as an anti-corruption expert for Transparency International. Prior to his academic career, he worked for the Serious Fraud Office participating in the first-ever English Deferred Prosecution Agreement. On that occasion, he was awarded, as a member of the case team, the UK Government Legal Department's Prosecutor of the Year Award. He is author of two books and several journal articles and chapters.



Dr. Lorenzo Pasculli – Assistant Professor in Law at Coventry University

Lorenzo is Assistant Professor of Law at Coventry Law School and a Sessional Lecturer in Conflict, Crime and Justice and Law and Professional Ethics for Science and Technology at Imperial College London. At Coventry University he is also an Associate of the Centre for Financial and Corporate Integrity and the founding director of the Global Integrity Research Network (www.girnweb.com). He is also a Fellow of the Royal Society of Arts and a Fellow of the Westminster Abbey Institute. For his research,

Dr Pasculli visited several prestigious institutions both in the UK, such as Oxford University and Queen's University Belfast, and overseas, such as Columbia University (New York), Fordham University (New York), Florida International University (Miami), and Bahçeşehir Üniversitesi (Istanbul). Lorenzo have authored many publications, amongst which the award-winning book "The Measures of Prevention of International Terrorism and Criminal Trafficking" (Padua, 2012).



Dr. Donato Vozza – Research Associate at the Centre for Financial and Corporate Integrity, Coventry University

Donato carries out advanced legal researches at the CFCI of Coventry University focusing on corporate law. He holds a PhD in Internationalization of Criminal Policy and has published several scientific papers. He also took part in several international research projects on law matters. Donato served as Visiting Scholar at College for Criminal Law Science of Beijing Normal University and at the Max Planck Institute for Foreign and International Criminal Law. He is currently Guest Researcher at the

Research Centre on International Cooperation Regarding Persons Sought for Corruption and Asset Recovery in G20 Member States established by the Beijing Normal University. Prior to his academic career, he worked as an international lawyer expert in the areas of white collar crime and business ethics.





Course Overview

During this specialist training course, which will be provided both through classroom and distance learning, the participants will be offered 30 hours of teachings (three hours, five days a week for two weeks) in the areas of company law, trust law, corporate governance, financial crime, and corporate social responsibility.

In particular, through analysis of legal theories, practical case studies, and group discussions with leading scholars and practitioners in the field, the participants in this programme will gain an in-depth and critical understanding of some of the major topics in the area of Corporate Law. This specialist training course will also allow the participants to develop the ability to analyse problems of technical complexity and to apply adequate principles to their solution.

The programme will not only focus on the English national legal frameworks but will also include comparative elements related to different jurisdictions as well as the analysis of aspects related to the international dimension of the matters covered.

Examining topical issues such as corporate veil, financial crime, corporate social responsibility and the creation and management of a trust, the course will also equip participants with the varied skill set necessary to oversee complex projects, such as corporate risk management and stakeholder management.

Certificate of Attendance

Participants will receive a Certificate of Attendance from Ascheri Academy and the University of East London subject to regular class attendance (i.e., the participant must be present for at least eight entire training course sessions).

Course Objectives

This specialist training course seeks to achieve the following objectives:

Gain a knowledge of the various forms of business association and their comparative advantages and disadvantages;

Gain a detailed knowledge and critical understanding of corporate personality and its limits, including with respect to piercing the corporate veil;

Gain a detailed knowledge and in-depth understanding of; the promotion and incorporation of companies; the contents of the constitutional documents, their significance and their legal effect.

Gain a knowledge of the roles and functions of settlor, testator, trustee and beneficiary, identifying the constituent elements of a fully constituted trust;

Gain a knowledge of the classical and contemporary ideas about corporate governance and the most thorny issues related to this area of law;





Gain a critical understanding of the way in which the different corporate governance theories influenced the development of corporate governance solutions;

Demonstrate a critical awareness of the adverse effects that unethical governance choices might exert on the corporate world as well as on the broader society;

To establish participants' knowledge and critical understanding of corporate crime and select financial crime offences from a domestic, European and international perspective.

Gain a detailed knowledge and critical understanding of the role of the corporation in society and the theoretical arguments for businesses taking on ethical stances.

Study mode

The participants have two options for attending the course:

- Classroom: University of East London, Salway Road, Stratford, London,
- Webinar: Ascheri Academy uses GoToTraining platform for online training programs.

The course will also be recorded, and participants will be asked to sign a consent form for the use of images, video and sound recordings.

Fees
